### **HOW CFP WORKS**

### Mission

The Conference for Food Protection brings together representatives from the food industry, government, academia, and consumer organizations to identify and address emerging problems of food safety and to formulate recommendations and solutions. The Conference seeks to balance the interests of regulatory and industry stakeholders while providing an open forum for the consideration of ideas from any source.

Though the Conference has no formal regulatory authority, it has a profound influence on model retail food laws, regulations, and guidance documents among government agencies and minimizes disparate interpretation and implementation of food safety policy and procedures.

### **Objectives**

The Conference for Food Protection promotes food safety and consumer protection through the following:

- Identifying and addressing problems in the production, processing, packaging, distribution, sale, and service of foods;
- Focusing on and facilitating the food protection programs of its constituent members;
- Adopting sound, uniform procedures which will be accepted by food regulatory agencies and industry;
- Promoting mutual respect and trust by establishing a working relationship among governmental agencies, industry, academic institutions, professional associations, and consumer groups concerned with food safety;
- Promoting uniformity among States, Territories, and the District of Columbia;
   and
- Utilizing the US FDA, US CDC and USDA/FSIS as the primary channels for dissemination of information.mentation of food safety policy and procedures.

### THE EXECUTIVE BOARD 2021 - 2023

### CONFERENCE FOR FOOD PROTECTION ANTITRUST STATEMENT

This Antitrust Statement is to inform the Conference for Food Protection (CFP) Executive Board members and the general membership of CFP that whenever competitors within an industry gather together, appropriate care must be taken to ensure that violations of antitrust laws do not take place.

CFP functions, be they conferences, Board or committee meetings, by their very nature, bring competitors together. To avoid antitrust allegations it is necessary to avoid discussions of sensitive topics. Agreements to engage in product boycotts, restrictive market allocations, refusal to deal with third parties, and price-restraining activities are automatically illegal under antitrust laws.

An antitrust violation does not require proof of a formal agreement. There need not be written or verbal agreement to collude. Also, conversations regarding any of these sensitive areas may be construed as implicit violations. As a result, those attending CFP-sponsored functions should remember the importance of avoiding not only unlawful activities but even the appearance of unlawful activity.

The antitrust laws – the Sherman Act, Clayton Act, and the Federal Trade Commission Act – are intended to ensure free and open competition. Violations of these laws can have serious consequences for CFP and its members. Violations are felonies that can result in severe penalties and significant litigation expenses for CFP and its members. Even if a government or private suit is successfully defended, the cost and disruption of the litigation can be overwhelming. Taking antitrust precautions, therefore, is not only advisable but imperative.

For your protection, the Conference for Food Protection recommends that, should one of these subjects be brought up, it would be in your best interest to voice your objection and disassociate yourself from the discussion if it continues.



### **THE COUNCILS**

Three Councils are seated at the Biennial Meeting to provide forums for deliberating the Issues assigned to them. Each Council is made up of designated representatives across CFP constituencies. Non-voting advisors from the Federal Agencies and a Parliamentarian are available to each Council to offer needed advice. The Council Chair introduces each Issue and recognizes the Issue submitter (or representative) to provide a brief summary of the Issue. During discussion, the Council Chair recognizes members of the Council first, the submitter, and then the attendees from the audience, as time allows. A Council may decide by simple majority vote that it is necessary to refer an Issue to another Council. After careful consideration of the Issue, the Council then votes on a recommended action to forward the Issue to the Assembly of State Delegates; these actions are limited to — Accept as Written, Accept as Amended, or take No Action.

Councils are appointed to consider all Issue submitted and approved to move forward for deliberation. Each Council consists of 22 members, including a Chair and Vice-Chair. The affiliation of the Council members is established by the Constitution and Bylaws and the Council is assembled to achieve a balance between industry and the regulatory sector. Council membership also includes academia and consumer groups, and non-voting Council consultants designated by federal regulatory agencies. Council members are selected through an application process announced approximately nine months in advance of each biennial meeting.

Council I — has been assigned Issues that deal with laws, regulations, and model codes governing the safety of food. (Technical Issues regarding laws, regulations, and model codes may be assigned to Council III.)

Council II — has been assigned Issues that deal with matters relating to Constitution and Bylaws, Conference Procedures, memoranda of understanding, program evaluation, education, training, certification, and accreditation.

Council III — has been assigned Issues that deal with science and technology. Registered attendees are encouraged to attend the Council sessions and may choose to move between the concurrent sessions consistent with the discussion topics and their interest. Parliamentary procedure will be followed during council deliberations. Observers wishing to participate in the Council discussions must first be recognized by the Council Chair.

Committees are formed to carry out the work of the Conference between the biennial meetings. There are Standing Committees that report to the Executive Board and Council Committees that report to their respective Council. Committees communicate their findings in the form of final reports that are attached to Issues.

### THE ISSUES

### **NEXT STEPS**

Issues that successfully pass through the process at the Biennial Meeting result in recommendations that are sent to the Federal Agencies or other organizations for action OR they direct the Conference to extend and/or create committees to deliberate the recommendations finalized by the Assembly.

Within a few months after the Biennial Meeting, the Federal Agencies are required to respond by letter to the Chair of CFP to announce what action they will take on the recommendation(s). In the case of the FDA, any recommendations accepted by the FDA are incorporated into the subsequently-published Food Code.

If the Assembly has voted to approve new or continuing committee charges, then the committees are formed or reformed and begin work that will result in Issues that are brought back to the next Biennial Meeting. Thus the work of CFP continues.

### **HOW TO GET INVOLVED**



### The Assembly of State and Territory Delegates

The Assembly of State Delegates is seated on the last day of the Biennial Meeting. The role of the Assembly is to vote on the Issues sent to them by the Councils, including amendments to the CFP Constitution and Bylaws. A Delegate has been authorized by their agency to represent a State, Territory, or the District of Columbia food regulatory agency responsible for the enforcement of food laws and regulations.

### **Voting Procedures for the Assembly of State and Territory Delegates**

Each State is entitled to one (1) full vote and each Territory (American Samoa, Guam, Northern Mariana Islands, Puerto Rico, Trust Territory, U.S. Virgin Islands) and the District of Columbia is entitled to one-half (1/2) vote in the Assembly. When a State has more than one State food regulatory agency enforcing food laws and regulations for food processing, food service, retail food stores, and food vending, the vote may be divided into appropriate fractions. State agencies within each State must agree among themselves regarding apportioning their one (1) vote. Representatives of States with more than one Delegate may, during any meeting of the Assembly, reassign their voting privilege to another duly certified Delegate from their State by giving written notice of such action to the Conference Chair.

If a majority (simple or two-thirds as prescribed in the Constitution) of the voting Delegates vote "Yes" on Issues "accepted as submitted" or "accepted as amended" by a Council, the action recommended by the Council will be taken. If a simple majority of Delegates vote "No" on Issues "accepted as submitted" or "accepted as amended" by the Council, the Conference will take no action on the Issue. Voting options available to Delegates are "Yes," "No," or "Abstain."

If a simple majority of the voting Delegates vote "Yes" on Issues on which the Council took "no action," the Conference will take no action on the Issue. If a simple majority of the voting Delegates vote "No" on Issues on which the Council took "no action," the Issue shall be referred to the Executive Board for further consideration. The Executive Board will then determine the appropriate action to be taken.

Delegates may ask to have an Issue "extracted" from the Council's report for separate, individual discussion. Issues dealing with the Constitution and Bylaws and Procedures of the Conference are automatically extracted from the Council II report. Extracted Issues cannot be amended by the Assembly. Following discussion, a vote is taken on the recommendation for each extracted Issue and the Delegates may vote "Yes," "No," or "Abstain."
