2016 Issue # I-015

- 1. Develop recommendations on how the FDA Food Code addresses Unattended Food Establishments:
- 2. Continue to review the "Guidance Document for Unattended Food Establishments" and any existing guidance from FDA and others to update the CFP guidance document that could assist states when addressing the need to have alternative protective provisions in place when approving variances for entities that do not meet section 2-101.11 and 2-103.11 of the 2013 Food Code; and
- 3. Present their findings at the 2018 CFP Biennial Meeting.

COMMITTEE WORK PLAN AND TIMELINE:

- 1. The Food Code does not define unattended food establishments. Currently to comply, operators must apply for a variance from having a person in charge present at all times for each location and regulatory agencies must review and approve each variance request. The committee continued to build on work from a previous biennium committee.
- 2. The committee met via conference call approximately every 4-6 weeks during the months when committee work was completed.
- 3. The committee consulted with a food defense expert as well as the FDA assigned consultants.
- 4. The committee finished its charges and is submitting its drafted Issues to the Conference for Food Protection.

- Overview of committee activities: The committee reviewed and amended the "Guidance Document for Unattended Food Establishments" http://www.foodprotect.org/guides-documents/ and drafted a proposed definition of an unattended food establishment and language to add to the Food Code to address minimum requirements for an exemption from having a person in charge present at all times.
- 3. Charges COMPLETED and the rationale for each specific recommendation:
 - a. Revised the Guidance Document to assist regulatory authorities and the food service industry in the review, approval and operation of UFEs
 - i. Updated the Preface to reflect the current committee's charge(s)
 - ii. Provided more information to describe "bulk food" vs. packaged food
 - iii. Added new section describing acceptable types of beverage dispensing equipment
 - iv. Corrected Food Code section reference regarding cleaning of multi-use food contact surfaces
 - v. Combined previous sections (G) Security and (H) Routine Maintenance in the original document into a new section (G) renamed "Food Protection"
 - vi. Added additional information on posting information on the presence of video surveillance to address food protection
 - vii. Renamed "Routine Maintenance" to "Routine Service" to better describe the activities that are related to food protection
 - viii. Removed references to product rotation and removal ofrecalled foods as these are not currently required by the Food Code
 - ix. Renumbered remaining sections of the document
 - b. Developed proposed definition of an unattended food establishment to add to Food Code section 1-201.10(B)
 - c. Developed proposed additions to the Food Code section 2-101.11 to exempt unattended food establishments from being required to provide a person-in charge at all times.
