18	northeast region representative and Steve
19	Morris, Kansas Department of Agriculture was
20	reelected as the representative of the
21	southwest region.
22	Under local regulatory, Kelli Whiting,
23	Marion County Public Health Department was
24	reelected as midwest region representative and
25	Amber Daniels from Mecklenburg County Health

Page 13 Department, Charlotte, North Carolina was 1 2 elected as the southeast region representative. 3 In the industry, Todd Rossow, Publix 4 Super Markets, Lakeland, Florida. Retail food, Jason Horn. In-N-Out Burger out of Baldwin 5 Park, California, food service, and Dr. Keith 6 7 Jackson, Performance Food Group, vending and distribution in Richmond, Virginia. 8 In 9 addition, your executive board has affirmed the 10 appointment of the following members of the 11 position of council vice chair for the 2018 to 12 the 2020 biennium: Council I, Tom McMahan is 13 the new vice chair from Meijer, Grand Rapids 14 Michigan. Council II, Joetta DeFrancesco, from the Florida Department of Agriculture and 15 16 Consumer Services, and Council III, Christine 17 Applewhite, Connecticut Department of Health, 18 Hartford, Connecticut. 19 I want to also advise you that our 2020

20 biennial meeting will be held March 30th 21 through April 3rd in 2020 at the Grand Hyatt 22 Hotel in Denver, Colorado. The meeting is 23 three weeks earlier to avoid the Easter 24 holidays in 2020. This means committees will 25 have to conclude their work earlier in the

Page 14 1 biennium and issues will have to be submitted 2 by the end of 2019. Please put March 30th to 3 April 3rd, 2020 on your calendar now and plan 4 to attend. The dates will also be posted on 5 the CFP website located soon after the close of 6 this meeting.

7 I'm going to read the following statement as required by the CFP constitution 8 9 and bylaws. "A quorum must be present. Α 10 quorum is defined as the presence of registered 11 voting delegates from at least two-thirds of 12 the states with designated official delegates 13 in attendance at the conference meeting. Each 14 territory and the District of Columbia shall 15 count as one-half state in constituting a 16 quorum. A two-thirds majority is required to 17 change a procedure adopted at a previous 18 conference or to make changes in the 19 constitution and bylaws. Other actions require 20 a simple majority, unless specifically covered 21 by Robert's rules of order. The voting choices 22 are as follows; yes, no and abstain. A Council 23 recommendation cannot be changed. Voters are cast by a show of hands by the voting 24 delegates. Roll call votes are taken only if 25

13	that are very instrumental in making this
14	conference a success. First is the Food and
15	Drug Administration whose sponsorship of CFP
16	through a \$50,000 small conference grant made
17	it possible to support 61 state and local
18	regulatory attendees to attend with a travel
19	subsidy.
20	Second, I'd like to call your attention
21	to the 56 national and local sponsors who
22	contributed over \$177,500 to make this
23	conference a success. And lastly, as our
24	chairperson mentioned, our local arrangement
25	committee and local sponsors who supported the

submitted or as amended. Those are the yes
votes. The part two reports will be the those
that were no action and in Council II there
would be a third part to their report and it

Page 20 1 will have the issues that affect the bylaws. 2 We separate those out because the bylaw 3 votes gets a two-thirds vote so when you vote 4 you need to speak very clearly and distinctly so we can make sure we get those numbers 5 6 correct. It's very important to all the hard 7 work that you have done. The Council chair 8 will come up, provide their report and then 9 will entertain a motion to ask if there are any 10 extracted issues. Those extracted issues are 11 those issues that you want to pull out from 12 either of those for individual attention. 13 Those issues that are pulled out will be

14 extracted. We will handle those at the end of 15 that Council's report. Everything else gets 16 voted on as a group as a block. All those that were in the yeses, the excepted as submitted or 17 18 the excepted as amended you will vote on as 19 It will be one vote for the entire thing one. 20 so you have to be very careful if you vote yes 21 for that, that means you're accepting 22 everything that's in that list except the ones 23 that were extracted. If you vote no then that 24 means you accept nothing in that list except 25 the ones that were extracted. We're clear on

6	component of the extracted issues so that you

10	the decision that they made. If you want to
11	provide additional information, it's really not
12	an opportunity for us to revisit the issue.
13	People have spent a lot of time and a lot of

18	If you vote on the no action items,
19	those are the ones that have no item action.
20	When you vote yes on the no action you're
21	saying you agree with the Council's
22	recommendation as it's there. When you vote no
23	on a no action you don't agree with the
24	Council's recommendation. Those no actions
25	where you vote no will be referred to the

Page 22 1 executive board for further deliberation. 2 When you vote in the block, the yeses, 3 when you vote yes we agree with those Council recommendations for the ones that voted as 4 submitted or as amended, yeses, whatever is in 5 the Council recommendation is what stands. 6 Any 7 nos, those issues die and they come back to the next CFP probably. Okay? Do you have any 8 9 questions about that? I know we had a lot of 10 questions about it yesterday. Anybody have any 11 questions? I just want to be clear that 12 everybody knows what they need to do. Vote in 13 a block or extract the issue out. Okay? **A11** 14 right.

15 We will ask for a motion at the 16 beginning to bring the issues to the floor just 17 as you did in your Council deliberations, we 18 have to start somewhere and typically you'll make a motion to bring issues, I don't know why 19 20 I can't talk this morning, to bring the issues 21 to the floor. You accept as submitted the 22 issues that are there and then we'll start the 23 deliberation. It doesn't mean that you agree 24 with all of the things that are there, it's 25 just our opportunity to start the discussion.
