It is trite and obvious to say that much has changed since our last meeting and planning for the April 2020 Biannual meeting. For that meeting our plan was to focus on bringing a variety of new foods/processes and technologies for risk reduction to the CFP community. Our plan was to have Plenary sessions focusing on new and emerging technologies and a set of hands-on breakouts on new foods/emerging products (see below).

We are happy to continue on that path for April 2020, and if the board would like us to confirm commitments from our speakers we will do so with no change over the next month.

We have internally also have been discussing a shift in the agenda to a COVID-19/food sector program. Over the past 5 months NC State has been tackling outreach and science challenges of SARS-CoV-2 within the entire food sector, creating a consortium of primary and applied researchers and outreach individuals. If the board would like us to use the pandemic as a key jumping off point for CFP we would be happy to put together a program that captures the massive challenges that CFP members are encountering. We would envision speaker presenting on the science of the virus, persistence, transfer, inactivation and provide a framework for education with a focus on how organizations and firms that use the FDA Model Food Code as their foundational document.

As part of our current efforts at NC State we could put together a program that includes speakers from federal, state and local regulation world, industry, service providers and academia.
