On December 17, 2013, FDA issued a proposed rule to amend the 1994 tentative final monograph or proposed rule for over-the-counter (OTC) antiseptic drug products. In this proposed rule, FDA proposes to establish conditions under which OTC consumer antiseptic products intended for use with water are general recognized as safe and effective. This is an FDA CDER proposed rule, and not one of FDA CFSAN. While I believe this proposed rule is primarily intended to address concerns with antibiotics used with soaps for consumer packaged goods and retail sale, I am fearful this may have unintended consequences for food handling environments in both retail and food service operations that use antibiotic hand soap as part of the overall food safety risk mitigation efforts. I am not requesting this be raised as a late breaking issue, but rather I would like the board to have a brief discussion on this from a food protection perspective. Details of the FDA proposed rule as well as a quantitative risk assessment conducted by Dr. Don Schaffner are attached to this email. I will bring these as hand-outs for members of the board.

• FSMA Comments – Michael Roberson

From the last board meeting, discussion was held around consumer notification of recalls (issue 2012-I-012). On March 25, 2014, the FDA published an advanced notice of proposed rulemaking (ANPR) in the Federal Register soliciting comments, data, and information to assist the agency in implementing a section of the FDA Food Safety Modernization Act (FSMA). Additionally, on January 31, 2014, the FDA issued a proposed rule regarding the sanitary transportation of food. It would be appropriate to have discussion about these comments at the executive board meeting. In addition, the Board should decide if it wants to form an ad hoc committee to assist with the data collection process and submit comments from CFP to the FDA for these proposed regulations.

• Item #3: Ethics and Solicitation – Michael Roberson

Earlier this week, Tom Johnson of Johnson Diversified Products, Inc. issued an email to selected CFP members. The purpose of the email was to solicit support for 4 issues submitted to Council I and 1 issue submitted to Council III. In my review of the information, I question the ethical nature of the email and view it as a means of "winning votes." The board should consider the appropriateness of this, how to address the current issue, and if changes to C&B are necessary to address future solicitations.
