- 1. Progress on Overall Committee Activities
  - a. As of July 24, 2014 we have received confirmation from our initial list of committee participants.
  - b. August, 2014 we completed the list with as much a representation of constituency as possible.
  - c. In August, 2014 the Co-Chairs reviewed the Plan Review Guide (2008) and shared with our members.
  - d. We held a conference call on September 26, 2014 with a proposed agenda.
  - e. Conference Call held on Nov. 17 and Nov. 19, 2015 to continue updating the Plan Review Guide
  - f. Conference Calls were held on January 16th and February 18, 2015.
  - g.
