1. Overview of committee activities:

The committee has convened one conference call in 2017. Six of eight committee members were able to make the call.

The committee discussed at length options for a food service sector replacement for Becky Stevens-Grobbelaar (retired). David had previously submitted Larry Lynch with the National Registry of Food Safety Professionals for consideration. Janice attempted connecting with Larry unsuccessfully several times. Members urged that we try to find someone specifically from the food service sector but not exclude Larry for consideration. Dave indicated he would send out the lists of CFP members with their constituency identified so that committee members could use the list to advance the names of individuals they felt would be suitable food service sector representatives on the committee. The committee then engaged in discussion regarding best methodology for follow up with general attendees of the 2016 conference as well as prior sponsors. Late last fall the Committee Chair asked Dave to send out thank you emails to all prior sponsors and informational emails to all

prior sponsors. Late last fall the Committee Chair asked Dave to send out thank you emails to all prior sponsors and informational emails to all general attendees providing some details about sponsorship and its importance to the success of the Conference. Dave sent out both toward the end of 2016. It was expressed that those communications may have been ill timed as most companied had already set their 2017 budgets by the time communications were received and more importantly the communications may have been overlooked with all the end of year business transactions that were underway at the time.

The committee members felt very strongly that we should not make "follow up" calls to anyone as the calls could be perceived as hard sell tactics and have the opposite affect than we desired in making the calls.

The committee did agree that an email follow up should ensue again either early spring or early summer to prior sponsors (excluding those who have already affirmed continued support) and companies for members not already sponsors.

The Sponsorship committee received notification of intent to continue sponsoring the Conference from several companies and has already received full sponsorship payments from two companies (IAFP and NSF) and partial sponsorship payments from one company (HEB). Acknowledgement and a note of gratitude for continued support of the Conference was sent to all.
