- Take in the light and air with a walk in the Houston Arboretum or a canoe trip down Buffalo Bayou



# "A Deep Dive into the Science Behind the Issues"

Issues submitted to the Conference for deliberation are often based on the most recent, most advanced science around food safety. In preparation for the Council deliberations, the educational Workshop will focus on three food safety topics selected from the Issues submitted for the 2023 Biennial Meeting.

Each day, there will be a different topic discussed, with time for Q&A with subject matter experts. The goal of this Workshop is to provide a deeper understanding of the science behind the submitted Issues so that attendees are more confident in the discussion and deliberation process.

Additional information regarding specific topics and speakers will be available in February 2023 after the Issue submission period closes for the 2023 Biennial Meeting.

# **Issue Submission**

An "Issue" is a topic submitted for consideration to the Conference by any interested party which addresses an identified concern related to retail food safety and offers a recommended solution to that concern.

Issues are accepted ONLY through an automated ONLINE process. To assist in preparing an Issue for submission, the "Issue Pre- Submission Form," "Terms and Conditions for Issue Submission," and the "Issue Preparation & Review Process and Checklist" are all available on the Conference website at the following link: <a href="http://www.foodprotect.org/about/issue-submission/">http://www.foodprotect.org/about/issue-submission/</a>

The online Issue submittal process will open on Monday, December 19, 2022, and will close on Monday, January 23, 2023 (9 p.m. Eastern time).

Issues finalized and assigned for Council deliberation will be posted on the CFP website no later than March 15, 2023 (at least 40 days prior to the start of the 2023 Biennial Meeting).

# Access to the Issues is through the CFP website only

All finalized Issues may be downloaded and printed as needed. Attendees are responsible for bringing their own copy of the Issues (either electronic or hard copy) to the Biennial Meeting. Final Issue recommendations following Council deliberation will be posted on the CFP website on Thursday evening prior to the Assembly of State Delegates. Following the conclusion of the Biennial Meeting, final documents will be posted to the CFP website indicating the action taken by the Assembly.
